We also assist in drafting or refining your Corporate Executive Security Policy, ensuring clear articulation of eligibility, operational scope, and risk-based justification—aligned with governance, audit, and IRS substantiation requirements.

Upon completion, Omnium delivers a CPA-approved report suitable for board review, external audit, or regulatory inquiry.
